Commodore's introduction

Where did those 5 years go?

When I put my name down for Commodore, I had in my mind changes that I wanted to make but I was always conscious that there is always a danger that the balance of things can be changed and not for the best. I mean that Ashlett SC has always been a special club in so much that it has its own characteristics be it the place itself or the membership within and the secret is to move forward and improve things but not take away what the club is about. I hope you know what I mean.

My goal was to try and make Ashlett a happier place and a bit more harmonious as well as to move it forward, I feel that has been more or less achieved by listening to people and their needs and trying to implement those things.

When I took over as Commodore, we hadn't long been a limited company following the demise of the old Waterside Sports and Social Club and I was very fortunate that I inherited a pretty financially stable Club largely due to Mike Cooper and his committee.

New Tractor 2019

One of the first things we did was to go out and buy a new Tractor, it was two fold in so much that our original little Red Tractor was a tough little thing but not big enough or safe enough to carry out the tasks demanded of it but also I had in mind that we would be requiring a boat lifter (still undecided at the time) and it would need a substantial tractor



with the power, four wheel drive and hydraulics to work it. We formed a small study group and went in search of a new tractor with an agreed budget and eventually we found one near Devizes that we felt satisfied the Clubs needs and bought it.



Covid

Covid was if nothing else interesting, what a strange ime for us all, the Club closed down for quite some time but we as a Committee were quite active and when rules allowed we were out and about organising and rranging the build of the new Jetty, boat hoist and groundworks.

Jetty June 2020

n the background whilst all this was going on was the requirement for a New Jetty because the old one was deemed unsafe and was taken down. Phil Crossland took on the task of organising and Project Managing the build of the Jetty and I think it took years off him with



all the red tape and hoops he had to jump and fight through. It seemed a simple enough task but that wasn't the case, how long should it be? how wide?, how close to the slip could it be? How deep the piles? and so on. Nevertheless, he persevered and eventually planning was given and Niccols were engaged in the building of a fantastic jetty built out of New Forest Oak

Boat Lift

As I mentioned my plan was always for the Club to have its own Boat Lift and this was for a

number of reasons, mainly that the Crane was becoming more expensive, it was getting more difficult each year getting the crane down the lane, the fact that all the revenue was going to the crane company and not us but mainly to allow us to become totally independent. It is so much better for everyone being able to have a choice about when you want your boat lifting out. So, we formed a work group, and we carried out a lot of studies, but we had the advantage that The Axe Yacht Club who I new quite well had already gone down the same path we wished to go so why not a bit of plagiarism and learn from their mistakes. We then went on several visits to various locations to see examples of Townsend



Engineering boat hoists (Axmouth, Lyme Regis and Bridport) and finally decided that what we wanted would closely resemble the West Bay Hoist which was the latest built by Townsend and with a few tweeks that would suit us best.

Boat Park and Real Estate Alterations Whilst buying a boat hoist we had to consider how we would operate such a large piece of equipment within the confines of the Sailing Club, we had to make sure that the hoist could be manoeuvred freely and to that end we decided that a one way system should be adopted and both the Tractor and Hoist would

have to go through the compound which meant the road needed widening and strengthening as well as the gates made wider.

I've always been conscious that we are a business and that we have to use every bit of our real estate to its full potential and I had always thought that we should push out to the Club boundaries so we undertook some serious groundworks and cleared back to our fence lines and a by-product was the removal of years of rubbish and junk that had accumulated, this has allowed the Club to increase significantly its winter storage area and of course increase revenue.

This also allowed us to divide Cruisers and Sailer Trailers into designate areas and again maximise pound space, with a lot of hard work from Martin Lucas and Barry Andrew.

Dredging 2022

Pretty soon after I became Commodore ESSO approached me about doing some dredging and I will be honest I don't really know how it actually came about they, ESSO, claimed we asked for it but I know I didn't, but I wasn't going to argue.

It was explained to me that Ashlett Creek would be a small part of a Capitol Dredge which



means Esso would dredge around the Terminal and we would be a byproduct. As it happened the Capitol dredge never happened, but the Ashlett dredge did, this eventually happened but not until after a long wait whilst all the red tape was completed. Since then we have managed to get the creek pressure blasted to maintain our depths and areas thanks mainly to Carl Sharman negotiating with the dredging company. Because we have had dredging done we are allowed a licence exemption providing we stick to the MMO guidelines. I think everyone is in agreement that it has allowed us more flexibility to our coming and going from Ashlett.

Moorings

As with the Boat Park maximising our assets has always been paramount on my mind to keep a good revenue flow and this also goes with our moorings, and you will have noticed how hard the team has worked in clearing the Creek of years' worth of old ground tackle. Then relaying new moorings in a more economical way, I mean by this that we are not wasting space and sharing mooring blocks, creating more moorings and putting as many moorings as close to navigable channels as possible and ridding ourselves of useless shallow moorings.

Clubhouse

I think one of the nicest things to have happened within the Club was the renovation of the



Clubhouse. I had always thought that it had always looked like a Café, having visited so many other Sailing Clubs ours seemed a poor relation. So whilst in conversation with Alan Morrison I asked him what he thought if we went and bought some second hand leather sofas he said he was up for it and then we started thinking about décor. The rest they say is history, but Al got stuck into the decoration Sam Savage the lighting and I arranged furniture and voila! Since then Jacky Morrison with help from others have really looked after the place and safe to say you the members have benefited.

Toilets

Finally the toilet situation at the Club has deteriorated quite rapidly these last few years, I think I can remember over 30 years ago talk of upgrading the toilets and showers. I can remember Tom Hatch and his mate Brian welding up the septic tank, the building of a wall around the building, installing a pump and it goes on, I suppose it's the old saying that you can't make a silk purse out of a sows ear! Well finally a new toilet is on the way and should start to be installed around November of this year, I won't steal anyone's thunder about describing it but suffice to say it will be a vast improvement and thanks must go to Ade Lumb and Simon Lovelock for their hard work.

The Committee

All of these things I've written about could not have happened without the Committee and I have been very lucky to have had a fantastic collection of people who have formed the Committee over this last 5 years or so , sadly a few of them are no longer with us , Sharon Geary Harwood our treasurer, Sue Doyle who had served on the committee not just with me but many times including as Commodore and last but not least a good friend who really knocked a few of us for six when he passed, Martin Lucas, I can't talk highly enough of Martin he was such a grafter, full of ideas , nothing was ever too much and he was also for

me personally a great sounding board . im Hopwood is moving off the Committee as well as myself and yet another great servant to the Club as well as a wise old Owl keeping me on the straight and narrow, he has kept the Club running for many years, so special thanks go to him.

Being Commodore of Ashlett Sailing Club has been a privilege for me so a big heartfelt thank you to everyone; it's been fun. Chris Brown

- Lastly your committee has decided to increase membership and services fees for 2025/26 by 4% to keep up with inflation and build up funds for future projects.

Membership

The introduction of Webcollect, our new membership system was no mean feat, and despite 18 months of work, there were still a couple of teething issues. However, we now have a very stable membership subscription platform, which helps us to account for our membership and boating subscriptions, all in one place. It is also integrated with our accounting software, so that the Treasurer has instant eyes on where the money is coming into the Club. Webcollect is now integrated within the Club website as ashlettsc.org , so everything is available at the one place, but you can still log on through the original portal if you wish.

Currently you are adle to buy your subscriptions for memberships, moorings, and the boathouse, as well as lift out for cleaning your boat and the Winter lift out program,

I hope to introduce more features throughout the year, and hopefully, by the start of next season you will be able to book social events and buy club regalia.

We are also using Webcollect to send you information, so it is really important that you update your account with any changes – email address, phone number and physical address

We have couple of membership enquiries each month, but often we are not able to accommodate the application because their boats are simply not suitable for the Creek, either too long of having a deep fin keel. We are also becoming limited because of mooring space, and this is likely to lead to a waiting list very shortly.

We currently have 18 probationary members, that is members who have been with the club for less than a year, some of those will become full members in the next couple of months.

We have 218 members, including those in family groups. 174 total memberships.

The RYA census has been filed and we will get the results of that at some point in the future.

Moorings and Creek

The end of the year has seen the completion of the mass refurbishment of the club moorings.

The team have lifted, refurbished with new chain, shackles and buoys, re-laid and dug in 47 moorings.

Over 22 old redundant blocks have been lifted from the creek, often involving forced water jets to break the suction of a great many years of clinging Ashlett mud! A huge amount of old rope, chain, buoys and other hazards were heaved into the skip.

Whilst of course, we still have to navigate around the ever-changing creek mud, the areas of free water have been enlarged and improved.

There are still a couple of small projects that will be worked as time and weather allow. Some repositioning of the first few moorings on the old East bank and maybe another two moorings laid alongside the sedge.

All moorings, 97 of them, are, at present, taken so a waiting list is in operation. There are two spaces for very shallow draught boats of perhaps twenty feet in length.

We are constantly evaluating the area with a view to squeezing in extra moorings but I think the creek is now full.

A big thank you to all who have helped us over the last few years in what is a very muddy job!

Compound and CCTV

I have a list of all the spaces with the owners and boat details which is regularly updated and I also have a plan showing all the spaces which is kept in the Bosuns Office on the wall. If you would like a copy of the Compound showing all the spaces and numbers, just email me.

We have cleared off all the paving slabs which identify the individual spaces and I am planning to number each space when we have good weather to do this. This will assist for identification purposes.

As a gentle reminder, can all members who have boats, trailers and equipment in the compound, please ensure it is clearly marked up. If any member is looking to store any boat in the compound please keep me informed so I can locate you a space and not just occupy a free space as it may be another member's space!

During the year we have improved some of our gardening equipment to make sure we keep the general areas of the compound tidy, weeds down and grass cut. I have had a number if mini work groups during the year with assistance from members and friends carrying out tasks within the compound.

During the year I organised the upgrade of our CCTV recording equipment and the installation of some additional cameras within the compound so we now have 9 cameras and have improved our overall coverage of your club and your boats.
